Re: Personnel Complaint MPD-II-12 made by Kimora Persaud

On Friday August 3, 2012 Kimora Persaud made a personnel complaint, against an unknown Officer, who she claims hung up on her, while she was speaking with her brother. Kimora's brother, Dellon Persaud, was arrested, by Officer Artola, Gallagher and Ribeiro (12-22012), and during the booking process he was afforded the opportunity to make a telephone call, at which time he called his sister, Kimora. Dellon's telephone call was ended by one of the Officers, causing Kimora to become upset. Kimora then called back and spoke with an Officer who was able to answer her questions and concerns related to her brother's arrest and his bail.

Based on this information I do not believe that Kimora has a valid personnel complaint, as the Officers were acting appropriately by limiting the length of Dellon's telephone call. Furthermore Kimora does not indicate that the Officer did anything inappropriate, other than hang the phone up, before she was finished speaking with her brother. In conclusion I do not believe that any further action is needed in regards to this personnel complaint.
