Dear Sir: I am making a formal complaint
Against PO Ahmad M. Artola shield 1249. On
the 8th day of Nov, 2010. P.O. Ahmad Artola
Approx 7:30 pm. brutally beat me with his
night stick while I was on the ground in someone's
backyard surrendring. He took his "billy club" in
hit me on top of my head twice, causing serious
physical injury + trauma to my head. I temporarily
lost recd consciousness and was awoken by him str 11



beating me with his club, on my arms, legs, and my mouth (lips). The pictures of this damage has been documented and the serious injuries I've sustained has been documented as well. As of right now I'm physically impaired without use of my right or left arms. I'm suffering from headaches morning, noon & night. PO Ahmed Artola should be reprimanded for this brutality for it was not warranted. Nowhere in his complaint, did he state I threatened him in any kind of way or anything to justify him beating me with his "bully club". He stated in his statement that I resisted an "authorized arrest for an active extraditable warrant from the town of Woodbury, N.Y." That is a lie, Sgt. Tabori told my wife the following day on the 9th that they do not know the name of the agency". The basis of my arrest is void and the brutality will not go unanswered. My complaint is not against anyone but P.O. Ahmed Artola and civil action will soon follow.

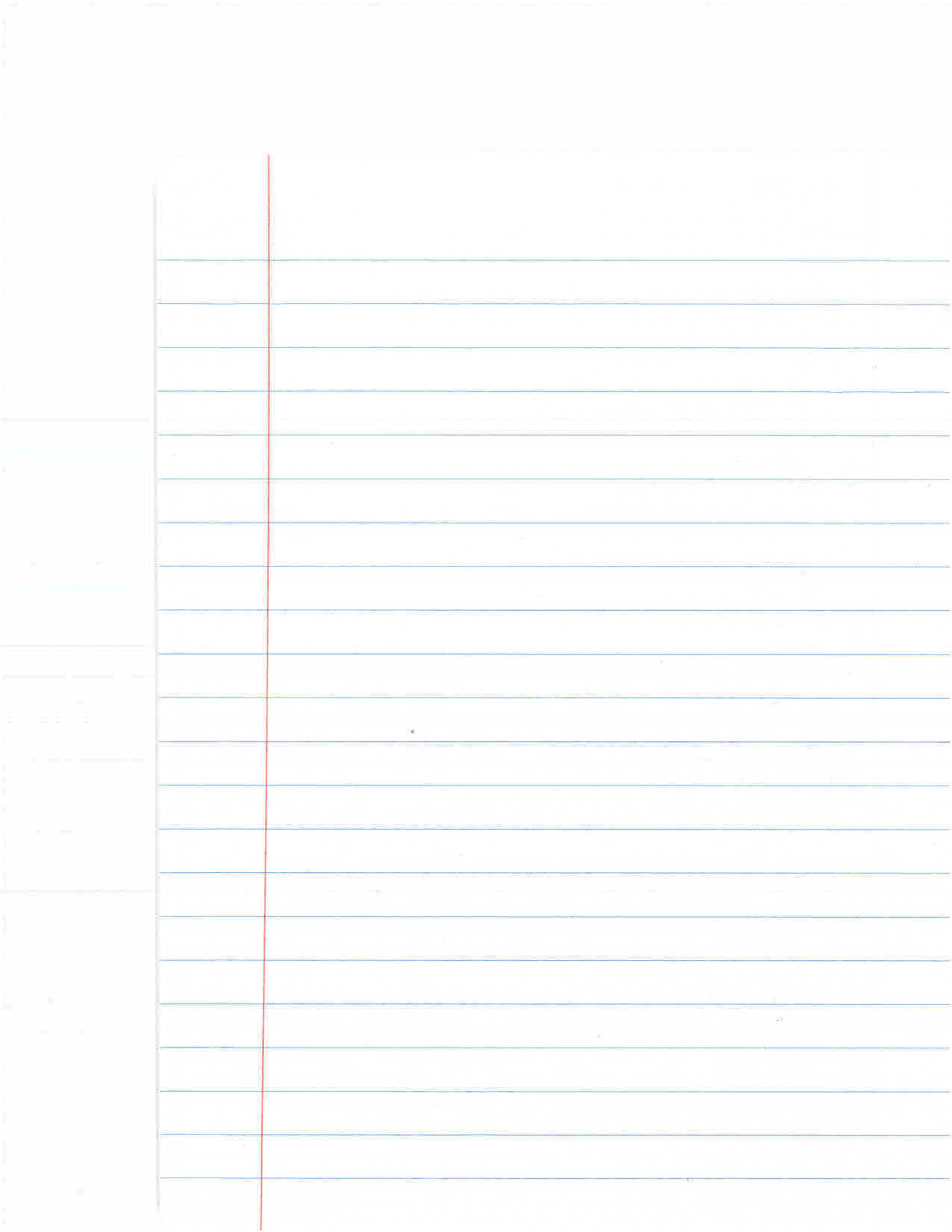

I was strongly advised by my Civil Attorney Michael H. Lusman to submit a formal Civil Complaint to your office concerning an excessive use of force by your Police Officer Ahmed Antola shield #1249 on Nov 08, 2010. Your office has yet to forward me the pictures of my injuries sustained on the evening of Nov. 08, 2010. I submitted 2 FOI request to your dept for said information, yet your dept. has not abided by the law concerning this instrument. Your Police Officer said that I resisted arrest yet on Jan 10, 2011, the Honorable Peter Brockett dismissed these fabricated charges in the interest of justice. I also know that your officer, Mr. Ahmed Antola has taken the stand at a Pre-Liminary hearing and trial where the jury rejected almost his entire testimony. His behavior is totally driven by his inability to control his emotions which obviously clouds his judgment. He made many errors that might beginning with never I doing me, leaving his patrol car unattended and losing his "property" which was announced over his radio. Review the Camcass from Double R, the one in Park Circle. My kids seen my condition on-line and they were devastated.

Dear Sir:

This is a formal Civilian Complaint against the Middletown Police Dept and Officer Ahmed Antola shield # 1249. On the evening of Nov 08, 2010 I Robert E. Morganfield became a victim of police brutality through the use of excessive force administered by Police Officer Ahmed Antola shield # 1249. From that incident, I suffered a concussion, severe contusion on the front right side of my head, contusion & trauma to my mouth in which I received a split lip & chipped tooth. I suffered bruises to both legs, a severely sprained wrist and deep bruising to my right elbow. The time of incident was approx 7:20 p.m. location started on North St and up Wickham and ended behind 190 North St apt. parking lot. On that evening I was leaving out of Double R Clothing store located on North St. and as I was stepping toward the road I noticed a Police Cruiser Occupied by Police Officer Ahmed Antola come to an immediate halt. Before he got out the car I proceeded to run and ran left up Wickham Ave and into the back yard of a residence. Police Officer Ahmed Antola shield # 1249 gave chase and as I jumped over a fence in the yard, Officer Antola yelled Stop, Middletown Police Officers under arrest. I immediately stopped & surrendered with my hands on the
