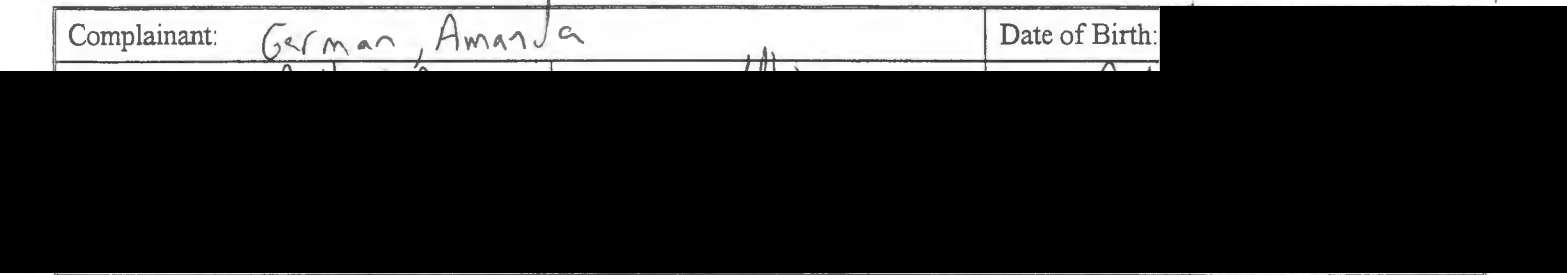


# CITY OF MIDDLETOWN POLICE DEPARTMENT PERSONNEL COMPLAINT
