SHE STATED THAT ON SATURDAY, 9-18-04 AT 11:25 PM SHE RECEIVED A PARKING TICKET ON KING ST. SHE FURTHER STATED THAT SHE IS NOT DISPUTING THE PARKING TICKET BUT FELT THAT THE OFFICER WAS ATTEMPTING TO PUSH HER INTO A CONFRONTATION BY FIRST STATING THAT HE WAS GIVING HER A BREAK BUT THEN CHANGING HIS MIND AND WRITING THE TICKET. CHAPMAN FILLED OUT THE DEPARTMENT PERSONNEL COMPLAINT FORM WRITING OUT HER STATEMENT OF ALLEGATION. I COMPLETED THE TOP OF THE FORM INCLUDING THE WITNESS INFO AS PROVIDED. CHAPMAN READ AND SIGNED THE AFFIRMATION ON THE FORM. I EXPLAINED THE COMPLAINT PROCEDURE TO CHAPMAN AND ASKED HER IF SHE WOULD LIKE ME TO HANDLE THIS COMPLAINT WITH THE OFFICER. SHE STATED THAT SHE WOULD LIKE TO CONTINUE ON WITH THE FORMAL WRITTEN COMPLAINT AND PURSUE THIS MATTER FURTHER.
