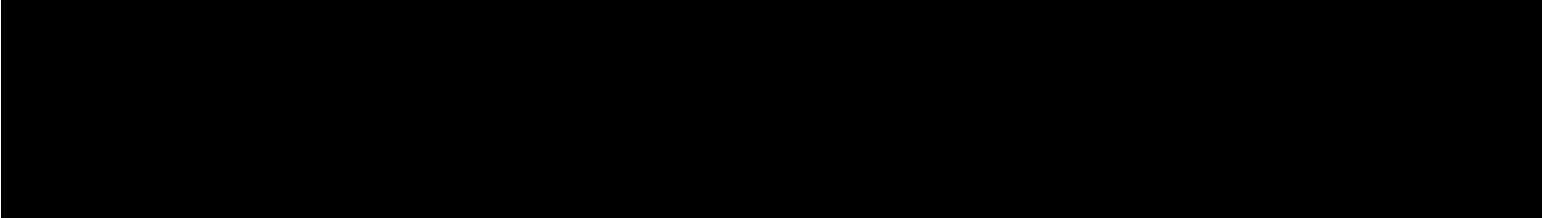


# CITY OF MIDDLETOWN POLICE DEPARTMENT PERSONNEL COMPLAINT

Details of Incident (CONTINUED) everything worked out and there was no retaliation. His two friends approached me and then the situation escalated and this guy began to scream and yell. The others approached this guy and wished him I try to go back in the Empty Bottle but they would not let me, I walk to far across the street leading toward, past Bobby's and I was stand in the park across from Empty Bottle waiting for my girlfriend. The guy who got arrested had a friend there who approached my girlfriend and began talking about her sucking his dick. I responded that this guy to come to me and suck my dick. The cops crossed the street but never said anything so I walked away at the advise of my friend I got to Dhru when an officer said idy you so I turned back around and I said Excuse me are you talking to me and the officer said yes you are under arrest. I questioned why I was being arrested and another officer slammed me on the ground (close lined me to the ground). I ~~hit the right side of my face~~ I fell to the ground and only hit my two elbows and my left ~~my~~ head did not hit the ground, my nose did hit the ground. I was on my stomach with my hands up to my side and another officer jumped on me and ~~was~~ had his knee on my head and was bouncing his knee on my left temple. I felt pain to the right side of my face so I picked my head up and said Sir you are hurting me. The officer said to me that does not hurt. I was humiliated, picked me up and drove me to the police station and told me that he was going to handcuff one hand to the bar and leave the other hand free and he was going to lock me up.
